New Technical Handbooks

From April 1st 2024 the new Technical Standards will come into enforcement. Guidance of the requirements to comply with the new standards comes in the following format:

- <u>Building Standards Division; Domestic Technical</u> Handbook; April 2024
- <u>Building Standards Division; NON-Domestic</u>
 Technical Handbook; April 2024

Summary of Changes

- The Technical Standards have been revised to prohibit the use of heating and cooling systems located within the curtilage of any new building, which produce more than a negligible level of greenhouse gas emissions.
- To implement this change, the 2024 technical handbooks introduce standard 6.11 (Heating and hot water direct emission heating system), associated amendments to standard 6.1 and guidance to standards 6.1, 6.8 and 7.1.
- The handbooks are otherwise unchanged from the June 2023 (December addendum) version.

New Fee Structure 1st April 2024

- Building Warrant: please see new scale at above link
- Amendment to Building Warrant: 0-£5,000 = 150.00
- Demolition Warrant Only and Conversion Warrant Only: £400.00
- Late Building Warrant: Building Warrant Fee times 200%
- Completion Certificate where No Building Warrant was Obtained: Building Warrant Fee times 300%
- Certificate of Design discount: 0-100,000.00 = between £40.00-£110.00, above this is 10%.
- Certificate of Construction discount: 0-100,000.00 = £20.00-40.00, above this is 3%.
- Letter of Comfort to be confirmed in due course.
