Technical Handbooks

Latest edition in effect from 01 January 2025.

From 1st January 2025, the latest amendments to the Technical Handbooks will apply. These are available on the Scottish Government website:

<u>Building standards technical handbook January 2025: domestic</u>
<u>Building standards technical handbook January 2025: non-domestic</u>

Summary of Changes:

Full details of the changes can be found in the handbooks. Brief points of note are:

- Standard 6.11: Heating systems using Bioenergy and Peat, and secondary heating systems are now excluded from the standard. Minor consequential changes are made to standards 6.1 and 7.1
- 4.14 changes to require 'Gigabit-ready physical infrastructure', including on-site physical infrastructure within the development site
- 2.15 refers to the section 3 Ministerial Direction specific circumstances and conditions where the provision of an automatic fire suppression system (AFSS) is dispensed with when extending a dwelling or undertaking a conversion to create, or increase the area of, a dwelling
- Appendix A "Defined Terms have now been updated.

New Supplementary Information Forms

We have new forms available to clarify the information required for the following circumstances:

Disabled Adaptations

The building warrant fee is set at zero for works to alter or extend a dwelling to improve its suitability for use by a disabled occupant.

If this applies to your proposal, please complete and attach the below form to your application through the eBuilding Standards portal. This supporting document for your building warrant application needs to be completed by a healthcare professional who agrees the adaptations are necessary. We do not require an individual's specific medical information.

Alternative Means of Compliance

The Technical Handbooks expand on regulation 9, detailing the mandatory functional standards. By following the guidance in the technical handbook in full, the mandatory standard is deemed to have been fulfilled.

Should you wish to deviate from the guidance this is known as an alternative means of compliance. In this case, you require to provide detailed supporting evidence. This evidence needs to demonstrate that the design provides equivalence to the technical guidance and therefore achieves the mandatory technical standard.
